1. These animal/s shall not be changed or replaced unless prior approval in writing is obtained from the Manager Health, Regulatory & Lifeguard Services or his delegate.
2. The animal/s are to be effectively contained within the property and kept in accordance with Council's Local Laws at all times.
3. The animal/s are not to be permitted to cause a noise nuisance to the residents of the surrounding area.
4. Identification (Registration where necessary) of the animal/s referred to above, is to be effected **immediately** with this application and renewed annually.
5. Such other conditions as the Chief Executive Officer or his delegate may from time to time impose.
6. Should approval be given to this application such approval will not extend to approving any other statutory or Local Government requirements relating to the property.
7. Lodgement of this application does not constitute registration of the animal/s and Council reserves the right to refuse applications.
8. If this application is not approved, the excess animal/s must be removed from the property within fourteen (14) days.
