A site plan (to a scale of 1:100) showing the relative locations of all animal enclosures, including (if applicable) details of all stormwater and waste water drainage within the subject site, and the designated area on site for the storage of waste generated by the activity; and 2. Details on the methods and procedures employed to ensure that the holder of the permit cares for the animals in accordance with the appropriate standards; and 3. Details on the methods and procedures employed to ensure that the holder of the permit manages the animals in such a way that the likelihood on nuisance, inconvenience or annoyance to the occupiers of the adjoining land is minimised.
