Purpose of this form

The purpose of this form is to request a Flood conveyance check for a potential Express DA. A Flood conveyance check has been established to advise the applicant if Flood conveyance matters will determine whether an application can proceed through the Express DA process.

A Flood conveyance check is only required when the subject site is identified on the Flood overlay map and the applicant intends to submit an Express DA at a later date.

Advisory notes

1. The Flood conveyance check must be undertaken before an Express DA is lodged.
2. This check is for potential Express DA **only**. Where it is clear the proposed development would not be accepted as an Express DA, the requested flood conveyance check will not be undertaken and the applicant will be advised accordingly.
3. City officers will respond via return email within 3 days from receiving a properly requested flood conveyance check. This response will advise whether or not flood conveyance affects the proposed development and if the development can proceed to pre-submission as part of the Express DA process.
