 - HOLES AND RADII ±0.5mm UNLESS SPECIFIED OTHERWISE.

**TIMBER NOTES :**

1. ALL TIMBER TO BE KILN DRIED (10-15% MOISTURE)
2. 'SELECT' GRADE, SAP WOOD FREE.
3. ALL SURFACES TO BE DRESSED IN ACCORDANCE WITH AS2796
4. ALL LENGTHS TO BE FREE FROM DEFECTS- KNOTS, WARPS, TWISTING, BENDS, HEART.
5. TOLERANCE ON DOCKING OF SPECIFIED LENGTHS ±0.5MM.
6. ALL EDGES TO BE ARRISED - EXCEPT WHERE RADII ARE INDICATED.
7. ALL TIMBER TREATMENT TO TAKE PLACE PRIOR TO FIXING.
8. ALL SURFACES TO BE TREATED.
9. CROSS GRAIN CUTS TO BE SANDED TO REMOVE BURRED EDGES.
10. MOUNT SLATS CENTRE DOWN
11. PREDRILL SLATS PRIOR TO SCREWING TO AVOID SPLITTING
12. CERTIFICATES OF SUSTAINABILITY FROM FOREST TO MILL MUST BE SUPPLIED WITH ALL TIMBER SECTIONS.
13. IMPORTED TIMBER NOT TO BE USED.

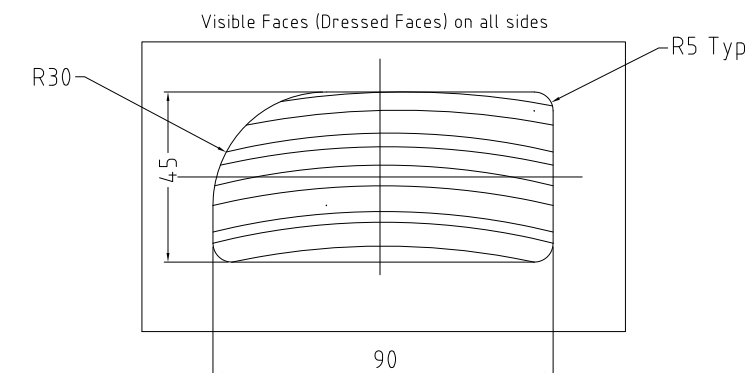
**SPA'N'DECK APPLICATION**

1. APPLY SND POWERLIFT TO DAMP TIMBER AND LEAVE ON SURFACE FOR 10 TO 15 MINUTES. DO NOT ALLOW POWERLIFT TO DRY ON SURFACE. IT IS PREFERABLE TO WASH OFF USING A POWER WASHER WITH A MINIMUM PSI OF 1,500 OR THE BEST MAINS PRESSURE AVAILABLE.
2. DILUTE SND PREP 50% WITH WATER. APPLY IMMEDIATELY AFTER THE POWERLIFT HAS BEEN REMOVED. LEAVE ON FOR 10 TO 15 MINUTES. DO NOT ALLOW TO DRY. WASH OFF WITH A POWER WASHER HAVING A MINIMUM OF 1,500 PSI OR BEST MAINS PRESSURE AVAILABLE.
3. APPLY THE FIRST COAT OF SND TO THE WET SURFACE DIRECTLY AFTER THE SND PREP HAS BEEN REMOVED, NOTE THE SURFACE MUST BE WET, JUST DAMP IS NOT ENOUGH. ALLOW TO DRY, 1 HOUR AS 25° C. APPLY THE SECOND COAT TO THE DRIED SURFACE. ALLOW TO DRY BEFORE APPLYING THE THIRD COAT.

**NOTE:**  
IF USING THE SND WHITE OR DRIFTWOOD, REDUCE WITH WATER AT THE RATE OF 50% TO ALLOW CLARITY OF THE WOOD GRAIN.

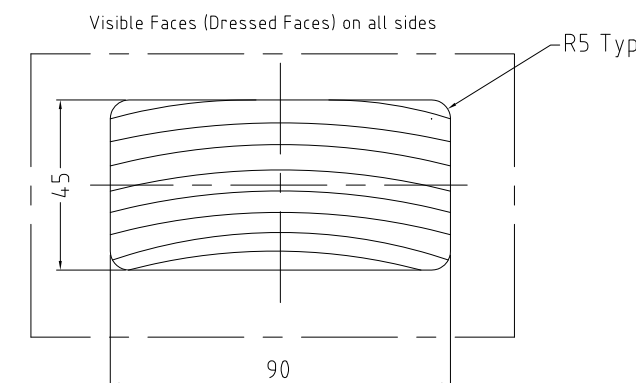

**NOTE: SLAT ATTACHMENT** Use a jig or spacers to allow correct and even spacing of the slats. Position slats and pilot (Ø3.5mm) hole before securing with fasteners. Always predrill Timber Slats before fastening. Mount slats centre down.



**Timber Profile Front Slat**

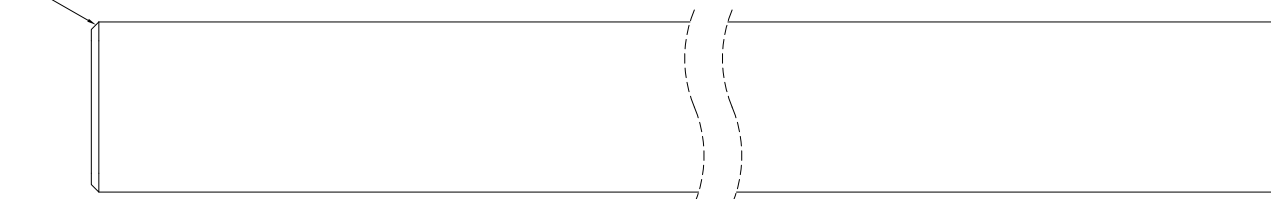

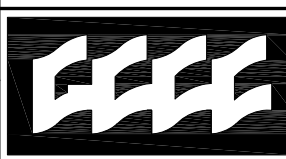
